However, 5-methyltetrahydrofolate (5-MTHF) is the biological form that is absorbed at the gut level, and transported across the blood brain barrier, which may offer more beneficial effects. Survivors often face lifelong impairments affecting functional status, memory, cognition, language, and mood, as well as physical functioning and metabolism. Within the past three years, a clear cause and effect has been established – post TBI hormonal deficiency syndrome. Prior to this new knowledge patients have been treated with symptomatic protocols that simply did not work. There is an increasing amount of evidence to suggest that post TBI hormonal deficiency syndrome affects many people who have sustained TBI and mild TBI, and research is now beginning to show that replacement of deficient hormones can lead to significant improvements. 15	<p>New Minimally Invasive Laser Treatment for Prostate Disease <i>Mahmood A. Hai, M.D., F.I.C.S.***</i> Over the last two decades, laser technology for the treatment of Benign Prostatic Hyperplasia (BPH) has undergone an evolution from theory to practical application. Recent studies have confirmed that KTP (potassium titanyl phosphate) laser resection of the prostate – otherwise known as photoselective vaporization of the prostate (PVP) – provides equivalent or superior clinical outcomes, lesser morbidity and lower overall economic burden when compared to TURP. It also provides a means of treating BPH in patients with co-morbidities that precluded TURP in the past. 36	<p>Ribose in Chronic Fatigue Syndrome, Fatigue, Fibromyalgia, and Heart Disease <i>Jacob Teitelbaum, M.D. **</i></p> <p>Mitochondrial dysfunction is thought to be an underlying or contributing cause of chronic fatigue syndrome (CFS) and fibromyalgia (FMS), and therefore we need to address whether anything can be done to make those cellular energy furnaces work better. This paper will discuss recent research showing that ribose, a key component of adenosine tri-phosphate (ATP), nicotinamide adenine dinucleotide (NADH), and other energy molecules that are critical to energy production resulted in an average 45% increase in energy after just 3-weeks of treatment. Ribose is also a key component of DNA and RNA and is deficient in energy depleted states. Because of this it is also very helpful in treating congestive heart failure (CHF) and other cardiac problems as well as generally improving athletic performance. Research on ribose in these areas will also be discussed.</p>	283

37	<p>Reducing Cardio Metabolic Risk <i>Frederic J. Vagnini, M.D.*</i></p> <p>The present day treatment of heart disease is strictly reactive. In other words, patients are given pharmacologic therapy for cholesterol, blood pressure, triglycerides, or diabetes, whilst the underlying metabolic, genetic, and lifestyle problems are ignored. The aim of this paper is to show by addressing the problem of cardiometabolic risk and treatment of any underlying metabolic disorders it is possible to prevent and reverse heart disease, and also prevent other diseases such as diabetes and Alzheimer’s disease.</p>	289
38	<p>Two New Aspects of Astaxanthin for Human Health: Metabolic Syndrome and Eye Fatigue <i>Eiji Yamashita, Ph.D.***</i></p> <p>Two new studies on natural astaxanthin, a carotenoid derived from the anti-aging microalgae <i>Haematococcus pluvialis</i>, revealed potential benefits for metabolic syndrome and eye fatigue. An animal study using metabolic syndrome model rats showed that 50mg/kg/day astaxanthin supplementation for 22 weeks significantly suppressed the development of metabolic syndrome by reducing blood pressure, fasting blood glucose level, and homeostasis index of insulin resistance, and improving insulin sensitivity. Astaxanthin administration also led to an improved adiponectin level, a significant increase in high-density lipoprotein cholesterol, and a significant decrease in plasma levels of triglycerides, and non-esterified fatty acids. Additionally, it showed significant effects on the white adipose tissue by decreasing the size of the fat cells. A double blind randomized placebo controlled human clinical study using visual display terminal (VDT) subjects (n=25 <treated> vs. 23 <placebo>) showed that 6mg/day astaxanthin supplementation for 4 weeks significantly improved visual accommodation during eye fatigue. The subjective questionnaire evaluating visual asthenopia revealed a marked reduction in “heavy head” claims. Other typical fatigue symptoms that showed improvements included “blurriness” and “stiff shoulders and back” in the treated group. Those findings suggest that astaxanthin is a promising natural candidate in lifestyle-related disease prevention and anti-fatigue, thus resulting in a decrease of medical expenses.</p>	293
